1. Background

In October 2020, the OPCC was approached by Highways England with an invitation to participate in a road safety project involving commercial vehicles on the strategic road network (SRN) across Devon and Cornwall. The project involves providing dashcams to up to three commercial vehicle fleets and assessing if the motoring behaviour of the driver is modified and improved due to the presence of the dashcam. Offences will be reported to Op Snap.

Project objectives are:

- To provide evidence of common behaviours on the SRN that may contribute to incidents and collisions
- To identify if and how driver behaviour changes once technology is installed in their vehicles
- To provide insight to Highways England, the police and other highways authorities on how drivers use the road network and whether there are any specific influences from the built environment (positive and negative).

The project will run for two years to trial the effectiveness of the intervention predominantly on the A38 in Cornwall between Saltash and Bodmin, a stretch of highway where there have been 10 fatalities, 42 serious injury collisions, and 169 slight injury collisions between 2014 and 2018.

The project is a partnership between Highways England, the OPCC and VZSW. This decision relates to £8,160 to be provided towards the project to be match-funded by Highways England.



2. Decision Record

2.1 To provide £8,160 to Highways England in match-funding towards the A38 Dashcam Project.

3. Consultation, Engagement and Communication

3.1 The proposal was initially put forward by Driving for better Business to the OPCC in October 2020. This underwent several revisions and was formally resubmitted in November 2020 by Highways England with match-funding secured.

The proposal has the support of Devon and Cornwall Police including the department facilitating Op Snap.

The project has secured additional funding from Vision Zero South West to cover additional project costs.

4. OPCC Monitoring Officer advice
