1.0 BACKGROUND

- 1.1 On behalf of the residents of Devon, Cornwall and the Isles of Scilly, the Police and Crime Commissioner (PCC) checks that the police service works well and meets the needs of its communities. The PCC also has to make sure that Devon and Cornwall Police are helping to deliver on the Police and Crime Plan. To do this the PCC 'scrutinises' certain issues and activities. To support the PCC in scrutinising Devon and Cornwall Police, and to openly and transparently show to the public how the PCC uses the scrutiny process, a Scrutiny Framework has been produced.

2.0 DECISION RECORD

- 2.1 A decision has been made that the Scrutiny Framework is fit for purpose and publication.

3.0 CONSULTATION, ENGAGEMENT AND COMMUNICATION

- 3.1 Devon and Cornwall Police's Chief Constable and relevant senior leaders from the police were extensively consulted during the production of the Scrutiny Framework. The Framework also featured as an agenda item by Joint Leadership Board and was considered by the Centre for Public Scrutiny.


