#### 1.0 BACKGROUND

- 1.1 North Devon Council submitted an application for a capital grant from the PCC to support the cost of upgrading the CCTV system in Barnstaple and Ilfracombe and upgrade the control room to provide onsite monitoring hub potential.
- 1.2 North Devon Council submitted a request for funding to the OPCC. The OPCC will support 40% of the costs.

#### 2.0 DECISION RECORD

2.1 The OPCC will award £46,000 to North Devon Council towards the total cost of CCTV improvements.

# 3.0 CONSULTATION, ENGAGEMENT AND COMMUNICATION

3.1 Prior to approval of the grant award, the proposal to purchase a CCTV system for North Devon was discussed with the local Police Inspectors. This provided assurance that there would be an operational benefit if a CCTV system was installed

# 4.0 OPCC MONITORING OFFICER ADVICE

## 4.1 Legal, Management and Equality Implications – Current and Future

The PCC's Chief Executive and Monitoring Officer has advised that the arrangements set out in the proposal meet the requirements of the PCC's CCTV Investment Strategy and the criteria for awarding capital grants.

The PCC's CEO and Monitoring Officer has advised that this decision is within the powers of those making it and that, from the information provided, there would not appear to be any adverse legal, managerial or equality implications arising from the proposal.

The grant awarded is no more than 40% of the total capital cost of the works.
