1. Background

- 1.1 Hayle Town Council submitted an application for a capital grant from the PCC to support the cost of purchasing additional CCTV cameras for use in Ellis Park.

2. Decision record

- 2.1 The OPCC will award £3,858.00 to Hayle Town Council for the total cost of additional CCTV cameras in Ellis Park. This amounts to 30% of costs.

3. Consultation, engagement and communication

- 3.1 The local police Inspector for Hayle has been consulted as part of this application and is fully supportive of the proposal.

4. OPCC Monitoring Officer advice

4.1 Legal, Management and Equality Implications – Current and Future

The PCC's Treasurer and Monitoring Officer has advised that the arrangements set out in the proposal meet the requirements of the PCC's CCTV Investment Strategy and the criteria for awarding capital grants.
