## Executive Summary

The PCC's Police and Crime Plan 2017-2020 'Safe, resilient and connected communities' sets out a commitment to support local authorities that wish to invest in CCTV systems. This commitment is part of the 'Supportive' element of the Local Policing Promise. The Plan sets out the PCC's broad approach to CCTV investment and undertakes to publish an overarching CCTV Investment Strategy.

The CCTV Strategy was published in February 2017. The Plan states clearly that the PCC's approach will be to provide a contribution to capital investment costs and that the focus will be on supporting the creation of interconnected, high quality and sustainable systems.

The OPCC have received an Expression of Interest from St Ives Council for a proposed upgrade, requesting a contribution of £13,911 towards their overall capital cost.

## Recommendation:

Approval of decision to commit £13,911 in grant funding contribution towards CCTV upgrade in St Ives subject to agreement of grant conditions with St Ives Council.
