1.0 BACKGROUND

- 1.1 The OPCC has been working with the Force to support and improve the provision of Community Speedwatch across Devon and Cornwall.
- 1.2 Community Speedwatch Online (CSW Online) is a cloud based portal provides a mechanism whereby volunteers can request new schemes, manage existing schemes, input results from CSW sessions, book equipment and bring in new volunteers.
- 1.3 The OPCC has agreed to fund access to CSW Online for Devon and Cornwall Police initially for a 12 month period, with extension options.

2.0 DECISION RECORD

- 2.1 *The OPCC will fund a one year contract (with extension options) between Devon and Cornwall Police and CSW Online for £9,000.*

3.0 CONSULTATION, ENGAGEMENT AND COMMUNICATION

- 3.1 CSW Development Group, chaired by Supt Drummond Smith has been driving the improvement of Community Speedwatch across Devon and Cornwall. This has included developing a new CSW policy, additional back-office staff support and included a trial of the CSW Online portal. The pilot was carried out between April and July 2019 which involved 9 CSW schemes from across Devon and Cornwall. The pilot was informed by data collection and surveying data from the participants. The overall response to the pilot has been positive from participants and the CSW Scheme Co-ordinator.

In October 2019 the CSW Development Group agreed to progress with the purchase of CSW Online for Devon and Cornwall Police on a one year contract with option for extensions for a further 2 years.

Joint Leadership Board has been informed.
