PURPOSE OF THE REPORT

The purpose of this report is to present to the members of the Audit Committee the number of fraud and investigations that have commenced since the last meeting of the Committee together with a summary of the number of investigations that have commenced since 1 April 2019.

1. INTRODUCTION

- 1.1 CIPFA guidance requires the Audit Committee to 'monitor the effectiveness of the control environment, including arrangements for ensuring value for money, supporting standards and ethics and for managing he authority's exposure to the risks of fraud and corruption.'
- 1.2 The term of reference of the audit committee give specific responsibility to review the arrangements for the assessment of fraud risk and potential harm arising from fraud and corruption and to monitor the effectiveness of the counter-fraud strategy.
