Executive Summary

- At the Joint Management Board on 23 May 2016 the Outturn Report and Appropriations to Reserves were considered.
- The overall spend is £930k below the budget and £276k below the forecast provided in March 2016.
- The approval of the £774k carry-forward requests leaves the overall spend £156k below the overall budget provision.
- The variation matches the under-spend on OPCC and Commissioning Budgets, this sum to be transferred to the Police AND Crime Plan Reserve to meet future Police and Crime Plan priorities.
